RELEASE AND HOLD HARMLESS AGREEMENT
FOR POLICE EMERGENCY VEHICLE TRAINING ACTIVITIES

THIS IS A RELEASE OF LIABILITY
PLEASE READ CAREFULLY BEFORE SIGNING

1. The Undersigned, is a current trainee that will be undergoing a course of instruction regarding the operation of police emergency vehicles at the Colorado State Patrol Academy Driving Track ("Track"), Golden, Colorado.
2. That I am over the age of 18 years and a current member of law enforcement or other public safety agency in good standing with my employer;
3. That I understand that the exposure to and operation of police emergency vehicles is an inherently dangerous activity, which involves the risk of serious bodily injury and/or death to me personally or others, from the acts or omissions of myself or others, including the use of any and all types of emergency vehicles or other equipment that may be used as part of such training activities;
4. That knowing the danger posed by such activities, I voluntarily agree to expose myself to such dangerous activities and fully understand the possible consequences of such decision;
5. That I hereby forever discharge, hold harmless and covenant not to sue, to the extent allowed by law, the State of Colorado, the Colorado Department of Public Safety, the Colorado State Patrol, the Colorado State Patrol Academy, their officers, employees, agents, heirs, personal representatives, and assigns, from any and all liability resulting from loss, damage or injury, that may be occasioned by my participation in any course of instruction or other activity that is part of police emergency vehicle training at the Track.
6. I further agree that I will abide by and obey all laws, rules, regulations, policies or procedures that may be in effect at the Track, including any verbal or written guidance or orders given to me during the course of my instruction at the Track by an authorized member of the Colorado State Patrol or Colorado State Patrol Academy staff.

I HAVE READ THE ABOVE RELEASE AND HOLD HARMLESS AGREEMENT. I UNDERSTAND ALL OF THE PROVISIONS OF THIS AGREEMENT AND THE RIGHTS I AM GIVING UP BY SIGNING THE AGREEMENT, AND I SIGN THIS DOCUMENT FREELY AND VOLUNTARILY.
